

Monopoly Deal

Oreot's "Unofficial" FAQ v1.2, 4-11-2011:

***GENERAL GAME INFO:**

Q - Ending the turn: does your turn end when you play your last card, or when you say you are done?

A - Your turn ends once you play your last card and rearrange your collection if needed.

Q - If you don't have enough money to pay a player, do you pay what you do have? For example if I have no property and only 1M on the table and someone charges a rent of 4M, do I lose my 1M. I.E. If I cannot pay in full do I pay in part?

A - If you owe rent, you must pay with what you have.

***HOUSES AND HOTELS:**

Q - Is it true that a player can move houses or hotels on their turn to other sets?

A - You may rearrange your property collection, but only on your turn.

Q - Is it true that hotels cannot exist without a house? (Meaning can I pay with a house and leave a hotel?)

A - You can only add a hotel to a property set after you've added a house. *(Oreot: See further down for dismantling rules.)*

Q - Is it true that a player can move a hotel to a new set without moving the attached house?

A - You can move a hotel card to another property set as long as there is a house already on the set.

Q- Is it true that hotels "replace" houses? (Meaning that a Set with a house and a hotel on it give a total of +4 to rent not +7)

A - Yes

Q - Yes or No. If I have a house played on a set and that set is broken up the house is added to my bank?

A - Yes. If you dismantle a full set that has houses and hotels, those houses and hotels have to go into your bank.

Q - Is it true that if a player gets a house as part of a payment and he doesn't have a set to play it on, that it stands alone among his property until he can play it on a set?

A - Yes

Q - If you play a house as an action does it retain its monetary value therefore is it able to be used to pay a debt? (Rent etc...)

A - Yes, you may pay rent with a house or a hotel.

Q - Can I use Sly or Forced deal to steal a hotel or house?

A - No, you may not use a sly or forced deal to steal a hotel or house card.

***JUST SAY NO CARDS:**

Q - "Just Say No!" can be played to counter a rent action card?

A - Yes. The Just Say No card can be used to cancel the effect when another player plays any Action card against you.

Q - Player 1 cannot use "Just Say No!" to cancel an action only affecting player 2?

A - True.

Q - If I use "Just Say No!" to cancel a rent action played against me. Everyone else still pays rent?

A - True. If you place the Just Say No card to cancel the rent. All other players must still pay the rent.

Q - If I use 'Just Say No' to cancel a double the rent card does it also cancel the rent card?

A - If you use a Just Say No card to cancel a double the rent card, it also cancels the standard rent card played as you can not play a double the rent card without playing a standard rent card. *(Oreot says: 'Double the Rent' states that it is played with a rent card, so they are played together and can be canceled together. Also, the FAQ does state that it counts as two of your three actions to play them.)*
